Connections

Generally speaking, water connections can be installed at the connection points in the utility ducts in Halle Nord and Halle Süd. As openings are unfortunately not possible along the entire length of the utility ducts, the taps for customer connections can only be installed at those points where the utility duct can be opened.

There are two types of tap.

Single tap

Drinking water supply is by means of a 1/2" drinking water hose through a shut off valve with check valve/backflow protection device installed in a construction profile frame.

Frame size W x D x H – approx. 40 x 30 x 20 cm



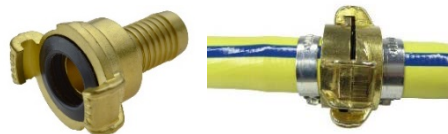
The delivery point to the customer tap is made of a GEKA Plus standard coupling:



Wastewater disposal is carried out using a wastewater pump station (W x D x H – 16 x 34 x 40 cm)

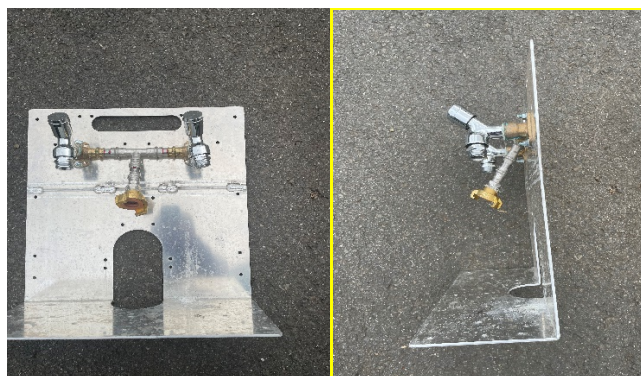


and a wastewater hose with a maximum diameter of 3.81 cm. The delivery point to the wastewater connection is also made of a GEKA standard coupling:



Double tap

Drinking water is supplied by means of a 1/2" drinking water hose via a shut-off valve with pipe isolator/backflow preventer installed in an aluminum profile frame. Frame size W x D x H - approx. 40 x 30 x 20 cm.



The fresh water supply and waste water disposal is analogous to the single tap. The required space for fresh water distribution and waste water lifting unit of approx. 40cm x 40 cm x 40cm in total is to be provided by the customer in any case.

If the tap cannot/should not be located at the spade channel outlet, a 1/2" fresh water hose and a 5/4" waste water hose must be run from the outlet above the shop floor to the proposed tap location. In these cases, the installation of a lifting floor (by the customer's stand construction company) with a minimum height of clear 4 cm is required to avoid tripping hazards on the stand. Alternatively, an appropriately dimensioned cable/hose duct can be laid by WICM GmbH at a charge.

Contractual terms and connection conditions

for water installations at trade fairs and exhibitions in the RheinMain CongressCenter Wiesbaden

1. The work includes laying water supply and drainage pipes to the respective exhibition/ trade fair stand whereby the distance from the main pipe is of no relevance, as an average value was calculated in this case. When placing an order, we kindly ask you to send us your desired connections by the mentioned return date; a surcharge shall be invoiced for orders received later, or the supplier shall reserve the right to accept an order.
2. The connection conditions are a component part of the agreement between the exhibitor and the installation company. Amendments are not permitted and do not represent any obligation to accept any order. The place of jurisdiction for the contractual partners is Wiesbaden.
3. The complete installation material and the devices are provided on a loan basis and remain our property. The customer shall be liable for the proper return of the same at the end of the exhibition. The rented objects are not insured by the lessor. Missing or damaged parts shall be invoiced at the original price. Material and rental devices that are removed from the event site shall not be taken back and shall be invoiced in full.
4. No liability shall be assumed for a potential water outage and damage. Furthermore, no liability shall be assumed for water damage incurred due to improper handling of the installed and connected devices as well as self-delivered objects. The exhibitor company is requested to take out insurance cover for water damage.
5. Water connections are only possible in exhibition rooms with parquet floors after advance clearance with the hall management and payment of a deposit.
6. Blockages that are caused by emptying unsuitable material (paper, fat, glue, coffee grounds) and require cleaning work shall be paid for by the exhibitor company.
7. The water supply shall be cut off if water is supplied to parties other than the contractual partner. The connection cost shall be paid even if the supply is stopped.
8. Complaints shall be directed to the installation company immediately, in any case before the exhibition begins. The installation company shall maintain their claim to full payment if complaints are not lodged in time.
9. **Special price agreements shall be made in the event of particularly difficult connections, missing drain pipes or pipes that are not easily accessible, or the use of waste water lifting pumps and the associated pipe routing over the ceiling of the hall.**
10. Apart from this, the regulations of the lessor of the hall shall apply. General rental and exhibition conditions §9 of the house rules.
11. A drawing including the desired installations shall be enclosed with the registration. If the desired stand supply point is not provided, we shall chose the most convenient place. A subsequent change shall incur additional costs.

Terms of payment

1. After order entry, the customer shall be sent order confirmation in the form of an invoice approx. 3 weeks before the event, which is payable before the trade fair begins. Only then shall the connection be taken into operation.
2. If, during the stand installation, overtime, Saturday or Sunday work is necessary due to late arrival (24 hours before the event begins), a 25% surcharge shall be added to the fixed price.
3. These connection conditions are a component part of the agreement between the exhibitor and WICM GmbH. Amendments are not permitted and do not represent an obligation to accept any order. The general terms and conditions of Wiesbaden Congress & Marketing GmbH apply, which are available for download at www.wiesbaden.de/avb. Upon request, we will send them to you.
4. Delivery shall take place on the last day of assembly.
5. The lessor is not responsible for delivery disruptions due to force majeure that make delivery difficult or impossible, even in the case of firmly agreed dates.
6. The rental goods shall be collected as soon as possible after the end of the event. In the event of missing, damaged or soiled rental goods, the lessee shall pay for the replacement, repair or cleaning in addition to the agreed rental price.
7. The liability of the renter begins with the delivery and ends with the collection. The rented goods are not insured by the lessor during the rental period.
8. The lessor reserves the right to deliver equivalent replacements in case of out of stock items.
9. Complaints are only possible before the beginning of the event. Later complaints will not be considered.
10. The general contract documents of Wiesbaden Congress & Marketing GmbH shall apply, which can be downloaded from www.wiesbaden.de/avb. We will send them to you on request.
