The following points shall be specified and documented as part of a risk analysis pursuant to §6 of occupational safety legislation:

1. Category of the pyrotechnical objects for stages and theatres:
 - Category T1 (I, II, III, IIII)
 - Category T2
2. The event organiser shall apply for the required fire protection measures at the latest 6 weeks before the first rehearsal before the event.
Agreement and approval shall take place with the responsible officer of the preventive fire protection department of the Wiesbaden fire brigade and, if necessary, an advance test of the effect will be required.
3. Effects with pyrotechnical objects and pyrotechnical compositions shall only be demonstrated if the effect has been previously tested for the intended use and there is written approval from the responsible officer from the preventive fire protection department.
4. Planning the set-up and the safety clearance to persons, decorations in accordance with the instructions for use for the objects shall be provided in dimensioned (digital) plans. In addition, the following points shall be addressed in the risk assessment:
 - Expansion of effects
 - Noise level + pressure
 - Thrust distance of fragments and burning or glimmering material
 - Flame formation + heat radiation
 - Glare
 - Safe burning off equipment
 - Body protection für stage personnel
 - Fire safety officer
 - Extinguishing agents
 - Humidification
 - First aid
